Sealed proposals for the **Street Rehabilitation Program (Ann St, Marla St, Midfield Dr, N Bradford St)** will be received by Village of New Haven, Clerk's Office, Owner, 57775 Main Street, New Haven, MI 48048 until **2:00 PM on February 26, 2020**, at which time the bids will be publicly opened and read aloud. Prospective bidders must have current **MDOT PREQUALIFICATION**, in the proper classification, at the time of the bid.

The project includes the rehabilitation of various existing pavement and sidewalk, approximately:
Cold Milling Concrete & Asphalt pavement 4,000 SY, Remove Concrete & Asphalt Pavement and Aggregate Base 2,000 SY, Remove Concrete Sidewalk 200 SY, Remove Driveway 150 SY, Remove Concrete Curb & Gutter 700 LF, HMA 1100T 1.5" & 2" 6,700 SY, HMA 1100L 1.5" & 2" 6,700 SY, 21AA Limestone Aggregate Base 8" & 10" (CIP) 4,000 SY, 6" Under Drain in Geotextile Fabric 700 LF, 4" Concrete Sidewalk 900 SF, 6" Concrete Sidewalk 400 SF, Station Grading 14 STA. In addition to Pavement Markings, Traffic Control & Maintenance, Maintenance Gravel, clean-up and restoration.
